Hello,

DEP has passed new regulations requiring schooling on regulatory requirements and safety. At the time of this letter there are three companies certified to give this training in Pa. One is in PhiladelOphia, one in Harrisburg and one from Wyoming (the State) training in Pittsburgh.

I am helping to set up classes for the Harrisburg company. They are willing to come here to hold classes locally if enough people sign up. There are four main things to remember.

- 1. This law applies to ALL registered underground storage tanks, whether you sell or not, private use, government use, etc.
- 2. Deadline for part two of law is August 2012
- 3. If not trained it will be illegal to dispense fuel after this date.
- 4. I suggest that you train early as human nature is to wait till the last minute. The certification does not expire, it is good for a lifetime, so nothing to be gained by waiting.

The first class is Dec 14th at the Hiram Andrews Center in Johnstown, Pa. At present it is over half full. Other classes will be in other locations, likely Altoona, Indiana and possibly Clearfield.

Part one of this law went into effect 6/28/2010. This relates to emergency procedure posting. Any questions, please call me at 814 244-9235.

Warzel & Sons has recently teamed up with Keystone Petroleum to provide Class A and B training as required under new DEP regulations. Keystone is a reputable Pa based company that has been providing service to the petroleum industry for many years.

Class A, B and C operators are required to be certified before August 8, 2012. If trained personel are not available on or after this date you must stop selling fuel or face fines if caught.

Please see below what is required.

Class A operator – best described as the big picture person. They must know regulatory requirements and ENSURE compliance on a company wide scale.

Class B operator – This person has site specific knowledge and is responsible for regulatory compliance at a specific location.

Class C operator – This is the store attendant / cashier. They must be trained in emergency procedure. NOTE that by 6/28/2010 every attendant or unattended location MUST have emergency procedures posted at site. Note that is an example only. The new regulations apply to ALL REGISTERED UNDERGROUND STORAGE TANKS whether selling or not. Also to private, commercial or government owned.

A company must have a trained Class C operator on an attended site any time fuel is being dispensed. This person can be trained by a Class A or B operator. Class A and B operators must go to an approved training course. A Class A can also act as a Class B or C. A Class B may act as a Class C. There are time limitations on Class A and B travel to site in an emergency.

Sessions will include specific responsibilities under new law, financial responsibility, new regulations, spill control, cathodic protection, overfill, sump regulations and much more.

This only covers a very brief overview and you should contact me or someone to explain full ramifications of the new regulations.
